

MINOR VISA FOR MINORS WHOSE STAY EXCEEDS 180 DAYS UNACCOMPANIED BY PARENTS OR RELATIVES

1. A copy of the completed application from The application form cannot be filled out on the WEB; it must be printed. It must be completed in Spanish. It must be signed. If it is not signed it cannot be processed.

2. A photograph no more than 6 months old, in color, of the applicant's face, size 32 by 26 millimeters, with a uniform, white and smooth background, taken from the front with the head completely uncovered and without dark glasses or any other garment that may prevent or hinder the identification of the person. (The photograph must clearly show the oval of the face and must be of high resolution and on good quality photographic paper).

3. Passport valid for at least the entire period of stay for which the visa is requested: Original and complete photocopy of all pages, even if blank; the photocopy does not need to be authenticated.

4. Proof of residence in this consular district, such as a receipt, a bank statement, or an electoral title: Original and photocopy; the photocopy does not need to be authenticated.

5. Proof of admission to an official or legally recognized educational institution in Spain to pursue or extend studies in Spain, in a full-time program, leading to the award of a degree or certificate of studies. Original and photocopy; the photocopy does not need to be authenticated.

The voucher must state: -Full name of the student. -Start and end dates of the course. -Full official name, address and contact information of the school.

6.1.1 Proof that the applicant has sufficient financial resources to support himself/herself during the period of stay in Spain, as well as sufficient financial resources to cover the transfer to another country or the return to the country of origin. Original and photocopies of all documentation must be provided; photocopies do not need to be authenticated. For your support in Spain you must have at least 564.73 euros for each month of stay.

6.1.2 The scholarship holders only have to prove their scholarship: This is sufficient to prove their financial resources. In the case of mobility programs for secondary or high school students, it is sufficient that the mobility program contains provisions that guarantee that the foreigner's financial support is assured within the program.

6.1.3 If not included in the cases of section 6.1.2. the following documents must always be provided: -Bank statements for the last four months. Originals. - Last four payslips or accreditation of income of the last four months in case of self-employed. Originals. It is not necessary to translate. You can prove the resources by exhibiting cash in convertible currency or by presenting certified checks, traveler's checks, letters of payment or credit cards; the latter must be accompanied by the bank statement or an updated bank book, or any other means with which the amount available as credit of the mentioned card or bank account is reliably accredited. Letters from banks or bank statements obtained through the Internet will not be accepted.

6.1.4 Non-scholarship students who are supported by their parents or guardians must provide a notarized deed from them, or common law equivalent, under penalty of perjury in a public document expressly and legally binding them to make available at least the amount of resources in 6.1.1 above. No translation or legalization is required. Please consult the notary for the text. In addition, the parents or guardians must provide the documents listed in section 6.1.3.

7. A single health insurance, public or private, arranged with an insurance company authorized to operate in Spain and covering the entire period of stay and all Schengen countries. This insurance must include all the risks covered by the National Health System for those who have the status of insured or beneficiaries thereof, without limitations or co-payments. It must cover those expenses that could be incurred by repatriation for medical reasons or death. Attention: In the cases in which the student participates in a program in which the institution that subscribes for him/her an insurance, this will be considered sufficient in case it covers all the risks normally covered for Spaniards. The original and photocopy of the individual letter provided by the insurance company and the receipt of the insurance payment must be submitted to the consulate. The photocopy does not need to be legalized.

1. Original and copies of criminal record certificates, legalized and translated into Spanish, issued by the Police and by the authorities of the country where he/she has resided during the last five years, not older than 90 days. You must bring a photocopy. If the criminal record certificate has been issued electronically, it must be accompanied by the original or authenticated copy and the identity document.

2. Original and photocopy of a medical certificate expressly stating that he/she does not suffer from any of the diseases that may have serious public health repercussions in accordance with the provisions of the International Health Regulations 2005, with signature authenticated by a notary public or the Health Professions Council of South Africa (HPCSA) and translation into Spanish. The certificate must not be more than 90 days old with respect to the visa application. There is no official model of this certificate. For more information and details about this certificate, please consult the College of Physicians or your own family physician.

In addition, the visa applicant must present and submit the original of the authorization of the father and mother, or, if applicable, of the guardians. The authorization must state the center, organization, entity and body responsible for the study, internship or volunteer activity and the intended period of stay.

If the signatory or signatories do not appear in person, the authorization must have the signature recognized in person before a notary.
